Taufiq offered a price of RM 120,000 for the restaurant but Samsol persuaded Fuad to sell it to him at RM100,000 as he would give coffee money of RM8,000 to Fuad for securing the deal. Fuad did not inform Alif of Taufiq's offer and accepted the offer of Samsol on behalf of Alif. After Alif signed the sale and purchase agreement, he discovered Taufiq's offer and the coffee money that Fuad received from Samsol. Being unhappy with the whole situation, Alif refused to pay Fuad's commission. Fuad intends to sue Alif for breach of contract,
