**QUESTION 1** **(20 Marks)**

Managing finances is a key activity in running any business, more so an early childhood education business. Thus, good financial planning is essential for the early childhood education center entrepreneur to manage the center's financial transactions according to the budget.

- a) The first task of the entrepreneur is to figure out the estimated cost of operating the business. Draft your own **start-up budget** and the **operating budget** based on your early childhood education center's needs analysis. (10 marks)
- b) Elaborate on THREE (3) sources of potential funding to start the business. (6 marks)
- c) Discuss TWO (2) impacts of poor financial planning. (4 marks)

**SOALAN 1** **(20 Markah)**

*Menguruskan kewangan adalah aktiviti utama bagi setiap perniagaan termasuk perusahaan yang memberikan perkhidmatan pendidikan awal kanak-kanak. **QUESTION 2**

**(15 Marks)**

Acts 308 and 550 ensure the security and clarity of those seeking to operate childcare centers and kindergartens in Malaysia. These policies also protect children in our care if we adhere to all of the acts' rules and regulations. Thus, understanding these acts is critical and must be known before starting a childcare center/kindergarten business in Malaysia.

- a) Discuss **FIVE (5) contents** of ACT 308 in relation to the requirements of setting up a childcare center in Malaysia. (10 marks)
- b) Elaborate on the **process** of setting up the kindergarten in Malaysia based on the contents stipulated in the ACT 550. (5 marks)

**SOALAN 2**

**(15 Markah)**

**QUESTION 3**

- a) State **THREE (3)** reasons why recruiting qualified staff is important for early childhood programs. (3 marks)
- b) Briefly describe **THREE (3)** strategies for dealing with excessive turnover in early childhood education and care staffing. (6 marks)
- c) As a kindergarten owner, discuss **THREE (3)** considerations when employing a teacher. (6 marks)
